The terms and conditions for auction shall be as under:

1. The bidder is required to submit the quotation along with EMD (Earnest Money Deposit) of Rs. 4,500/- (Rupees Four Thousand Five Hundred only) in the shape of Demand Draft in favour of "ESI Fund A/C No.2" payable at Tirunelveli. The EMD of unsuccessful bidder will be returned within two weeks after opening of bid. Bank account details of the bidder should be submitted along with the demand draft for the repayment of the EMD amount.
2. Quotation without EMD (Earnest Money Deposit) will not be considered and quotation would be treated as non-responsive.
3. Successful bidder will be required to deposit the bid amount with 03 days by Demand Draft in favour of "ESI Fund A/C No.2" payable at Tirunelveli. In case, he fails to make deposit of the total amount as per tender within the stipulated time, the deposit including the Earnest Money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment tender value in time.
4. The delivery of the sold items will be given only after the successful bidder submitted documentary evidence in support of Residential Status (PAN Card /Driving License/Voter ID, Aadhar Card, etc.,) and the payment of the bid amount.
5. The sold items shall have to be taken at its own cost by the successful bidder within 7 days on payment of bid amount.
6. The successful bidder shall not be allowed to withdraw the bid.
7. The committee constituted for the said tender reserves the right to accept or reject the any or all of the quotations without assigning any reason.
8. The quotations received will be opened by the committee constituted for this purpose.
9. The bidders or the representative (not more than one) with proper authority letter may be present, if they so desire at time of opening of quotations.
